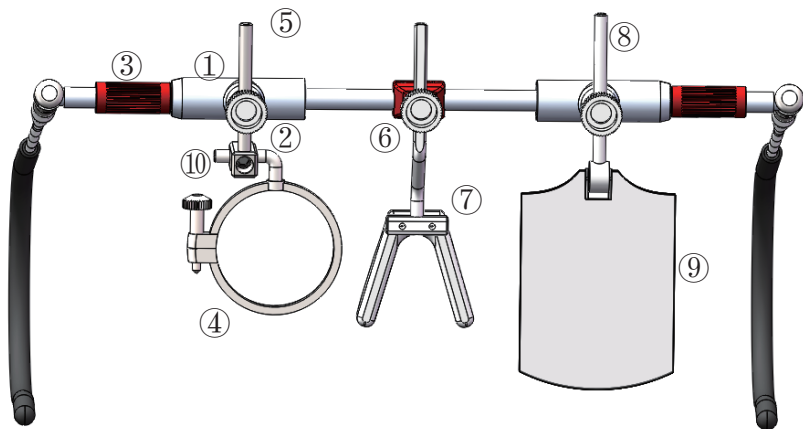

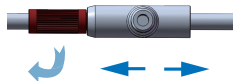

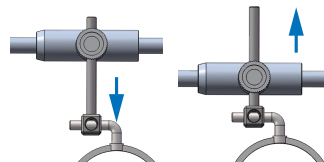
1, Adjust the relative position of lens holder and pupil

To rotate the Hand nut ③, and to drive Adjustable control ① to move in the beam, so, it make the user's pupil with Lens holder ④ in the right position. The same to the Eye-blinder ⑨.



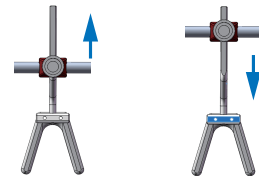
2, Adjust up and down position

To rotate the Hand screw ②, and to move Rod ⑤ up and down.



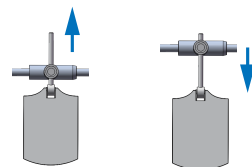
3, Adjust the nose rod height

To rotate the Hand screw ⑥, and to move Nose Rod ⑦ up and down.



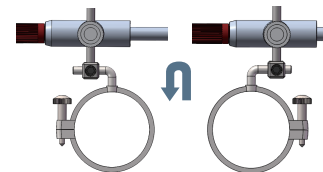
4, Adjust the Eye-blinder height

To rotate the Hand screw ⑧, and to move Eye-blinder ⑨ up and down.



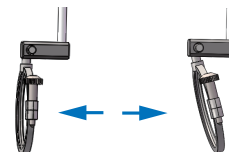
5, Adjust the Lens holder direction

To loose Socket set screw ⑩, and to changd the Lens holder ⑤ direction,

To loose Socket set screw ⑩, and to adjust the Lens holder angle.
